We are thrilled to host a 10-day in person summer camp, **CAMP OVERBROOK: IN SIGN 2021**. This year, it will take place on June 21 – July 2, 2021 at Saint Joseph's University (SJU), Maguire Campus on City Ave. Are you interested in a summer two-week job as an assistant camp leader? If you are, complete the assistant camp leader application online as soon as possible. For those who worked last year's camp, you still need to fill this out. We will be following all the Covid-19 protocols required by the CDC, state, county and St. Joseph's University. (<https://www.cdc.gov/coronavirus/2019-ncov/community/schools-childcare/summer-camps.html>) The detailed procedures will be posted and kept updated at [www.CampInSign.org](http://www.CampInSign.org). Mask wearing, distancing, enhanced cleaning/disinfecting, cohort planning and increasing the amount of outside programming will be put in place to reduce risk. Assistance will be required to follow these guidelines and assist the leaders in monitoring the campers to follow these procedures to create an enjoyable and safe environment.

The pay for assistant camp leader is \$75 for each week. Each day you must be able to arrive at camp by 8:30 AM; camp ends at 2 PM each day. Please be sure you're committed to work these 10 days of camp and willing to attend one training meeting. We will not be providing transportation this summer due to the Covid-19 restrictions. *You will need to provide your own transportation.* If you want this job you must be available to attend the camp orientation meeting which is tentatively scheduled for Thursday, June 17, 2021 from 2 pm to 4:30 pm.

All adult staff (18 and older) are required to have FBI Fingerprint Clearance, PA State Police Clearance and PA Child Abuse Clearance. Clearances for new staff must be no more than a year old. Former staff, clearances must be renewed within five years.
